Cover bookkeeping basics, assets and liabilities, managing budgets, auditing, double-entry accounting, etc.</i></p>

	<p>Pollack, Kenan and Heighberger, Eric. <u>The Real Life Investing Guide</u>. New York, NY: McGraw-Hill, 1998.</p> <p><i>An investment guide for young professionals which explains the basics of investing as well as gives practical advice for financial planning.</i></p>
